## TERMS AND CONDITIONS OF MEMBERSHIP

PLEASE READ, UNDERSTAND THE FOLLOWING CAREFULLY AND SIGN THE DECLARATION BELOW. IF YOU ARE UNDER 18, A PARENT OR GUARDIAN MUST ALSO SIGN.

1. *I accept to be a member of Wild Mustang Fitness for the duration of selected commitment period. When the commitment period ends, my membership will be automatically renewed to the nearest package or similar unless I inform Wild Mustang Fitness via email or handwritten letter to terminate my membership. If I terminate my membership before my commitment period, a cancellation fee equivalent to the remaining commitment time/amount is payable*
2. Upon signing this membership form, a non-refundable administration fee of **N\$100.00**
3. You must 'scan in' at the reception using your assigned fingerprint on our fingerprint reader at the entrance. **Entry will only be permitted to those with a valid membership, in date and in good standing. If you have an amount due to be paid on your account, you won't be able to enter the gym unless payment arrangements are done.**
4. You may, at your own discretion and expense, obtain personal insurance for loss, injury or damage that you might sustain arising from use of the club. **Please note that you exercise at own risk – Wild Mustang will not be held liable for any injury or harm caused while exercising. NB: Always ask HELP from available trainers**
5. Members who opt for a direct debit membership agree to join for a minimum of 6 months. The first month is payable in advance by cash or credit/debit card at the reception. This 6-month period is considered paid for after the 5th payment via direct debit order. From then on, the membership will roll over monthly. This will continue until the membership is terminated by member, via written notice to our email, [accounts@wildmustang.co](mailto:accounts@wildmustang.co). **NB: No Telephonic or verbal cancellations will be considered.**
6. Direct debits will be taken on the date, which the member best suits them. Your membership will commence on the start date and will continue for fixed number of full Installments that you have selected
7. **A valid proof of income should be provided upon signing up**
8. This is a contract-based membership, therefore whether you use the facility or not, your account should be kept in good standing. Members with 12 months membership or less have up to a maximum of **TWO** months to freeze their membership. Members with more than 12 months membership have up to **FOUR** months to freeze their membership. The frozen period will be added to the contract period. To freeze your membership, a freeze notice should be provided at least **FIVE DAYS** in advance either **telephonically** or by **mail**
9. Members who have chosen the **12 months** contract or less may NOT cancel their membership until the contract period expires, thereafter they will have the option to cancel at any time via written notice [refer to 5]. Members who chose more than **12 months** may cancel their membership by paying **80%** of the remaining months/amount as a cancellation fee.
10. Members are required to keep funds in their account to meet these payments. In the event of the failure to pay the monthly membership fee, missed payments will be re-submitted for payment by Wild Mustang accountants. Wild Mustang reserves the right to cancel membership if payment is not received. Access to the facility will be denied until said payment is received and if payment is not received, and cancellation occurs, the registration fee becomes applicable again on re-joining. **NB: Please note that we have the right to hand your account to debt collectors & ITC should you fail to make payment or make payment arrangement when deemed necessary over failed payment – Please honor your payment on time to keep your good credit rating. 11. Members, who opt to pay their membership over the counter, should pay at least three months in advance. Any subscription of 12 months or more is payable via debit order. Any other form of payment should be discussed and approved by management.
12. If you opt option for student and pensioner option, you may be given option to pay over the counter however reference should still be made to point 5, 8 and 9 above
13. Membership is not transferable. Members who are caught transferring their membership to others will have their membership canceled and a penalty of an amount equivalent to **60%** of their remaining month/amount is payable
